Dear Junior Club Counselors and Teachers:

Enclosed is the 2010 – 2011 Junior Music Club form to pay your annual dues to MFMC. Every entrant in a festival MUST be a member of a federated Junior Music Club and every teacher MUST be a member of a federated Senior Music Club or an INDIVIDUAL member.

Dues remain the same this year, \$1.25 per member with a minimum of \$25.00 per club. If your club has 20 members or less your dues will be \$25.00. This includes one subscription to Junior Keynotes Magazine. Additional subscriptions may be ordered for \$6.00 per year. EVERY TEACHER OR COUNSELOR MUST SUBSCRIBE TO JUNIOR KEYNOTES. If your club has students from more than one teacher, PLEASE remember to add those additional subscriptions.

If you are a member of a Senior Music Club, please list that club. If not, you MUST pay \$50.00 dues to become a Senior Individual Member. This includes a subscription to Music Club Magazine.

Any contributions to State or National scholarships and projects are voluntary. All money received for State Scholarships goes into the Scholarship Foundation. I have added a line for "Bucks for Brevard." This is a fundraiser to endow a scholarship to Brevard offered by the Southeastern Region of NFMC. They are requesting one dollar from every member. Again, this is optional.

It is also VERY important that you send a list of all club members indicating which are new members. National now requires I send this information.

The deadline for this report of DECEMBER 1, 2010. Any reports received after this date will be charged a \$5.00 late fee. My report to the national treasurer is due January 1, 2011, so please get your report to me as soon as possible.
